TERMS & CONDITIONS OF NIT

- The following terms and conditions will be applicable for the Group Personal Accidental Insurance Policy (GPAIS) under Bokaro Welfare Trust. Tender will not be accepted in case of any deviation from the terms and conditions mentioned below: -
- An annual insurance coverage of Rs.10,00,000/- per insured person under Group Personal Accidental Insurance Policy (GPAIS) is to be obtained for contract workers working under various contractors in Bokaro Steel Plant, in the event of death arising out of an accident as defined in the insurance policy.
- 3. The number of contract workers to be brought under insurance coverage is 17000 approximately. However, this number is dynamic in nature and may increase or decrease depending upon job requirement. The contract workers are in the age group of 18 years to 60 years.
- 4. Updated list of addition and deletion of contract workers in the insurance coverage will be provided by the Trust at a frequency as mutually decided so that all workers are covered under the policy at every point of time.
- The current rate of daily wages (gross including allowance) as notified by BSL for the contract workers
 to be brought under insurance coverage is between Rs. 658/- to Rs. 1148/- based on their skill category.
 However, their actual earning per month depends on their attendance.
- 6. The term of the policy shall be one year. The members shall be eligible for the benefits as per Annexure—
 1 in case of accident anywhere and at anytime in the world.
- The premium rate shall be fixed for the complete policy term of one year.
- 8. A contract worker will be allowed to join the policy anytime during the currency of the policy (as per the list provided by the Trust) and shall continue to be covered till the remaining period of that policy cycle. In that case, his/her premium will be deposited at a rate proportionate to the annual Premium as per the period for which he shall be under the coverage of the Policy.
- 9. In case of accidental death, besides a coverage of Rs.10,00,000/-, any inbuilt benefits provided viz. funeral expenses, ambulance expenses etc. may be clearly specified.
- The Insurance Company should preferably have an office in Bokaro Steel City, for speedy settlement of claims.
- 11. All the official documents issued by Insurance Company shall be duly signed with seal with the name and designation of the issuing authority.
